Appendix A – Excerpts from Relevant Legislation

The Tobacco, Smoking and Vaping Reduction Act, SA 2005, c T-3.8

Definitions

- 1 In this Act, ... (f) "public place" means all or any part of a building, structure or other enclosed area to which members of the public have access as of right or by express or implied invitation including
 - (i) the common areas of a multi-unit residential facility, including patios, pools, other recreation areas and enclosed parking garages,
 - (ii) a group living facility,
 - (iii) an outdoor bus or taxi shelter,
 - (iv) licensed premises,
 - (v) a restaurant, and
 - (vi) a hotel; ...

Smoking and vaping prohibited

- **3** Subject to section 5, no person shall smoke or vape
 - (a) on a hospital property, including the building, grounds and parking areas used in relation to the hospital property,
 - (b) on a child care facility property, including the building, grounds and parking areas used in relation to the child care facility property,
 - (c) on a school property, including the building, grounds and parking areas used in relation to the school property,
 - (d) in a workplace,
 - (e) in a public place,
 - (f) in a public vehicle,
 - (g) in a vehicle in which a minor is present,
 - (h) in or within a prescribed distance from any of the following:
 - (i) a playground;
 - (ii) a sports or playing field;
 - (iii) a skateboard or bicycle park;
 - (iv) a zoo;
 - (v) an outdoor theatre;
 - (vi) a public outdoor pool or splash pad;
 - (vii) any other place that is prescribed or otherwise described in the regulations, or
 - (i) <u>within a prescribed distance</u> from a doorway, window or air intake of any place referred to in clauses (a) to (e) and (h)(vii), as the case may be. [Underlining added]

Prohibition re minors

- 3.1 No minor shall possess or consume a tobacco product or vaping product or smoke or vape
 - (a) in a place referred to in section 3,
 - (b) in any outdoor place or area to which members of the public have access as of right or by express or implied invitation, including a highway within the meaning of the *Traffic Safety*
 - (c) in a vehicle that is in a place referred to in section 3 or in an outdoor place or area referred to in clause (b).

Municipal by-laws

- 10(1) Nothing in this Act affects a municipality's power to make bylaws to regulate, restrict or prohibit smoking or vaping.
- (2) Where there is a conflict between a provision of this Act and a provision of a municipal bylaw that regulates, restricts or prohibits smoking or vaping, the more restrictive provision prevails.

Gaming, Liquor and Cannabis Act, RSA 2000, c G-1

Use of cannabis in vehicles prohibited

90.24 Except as otherwise provided for in this Act or in a cannabis licence, no person may use cannabis in a vehicle unless, when the cannabis is being used, the vehicle is a temporary residence.

Smoking and vaping prohibited

- 90.28 No person may smoke or vape cannabis
 - (a) <u>in any area or place where that person is prohibited from smoking under the *Tobacco* and *Smoking Reduction Act* or any other Act or the bylaws of a municipality,</u>
 - (b) on any hospital property, school property or child care facility property,
 - (c) in or within a prescribed distance from
 - (i) a playground,
 - (ii) a sports or playing field,
 - (iii) a skateboard or bicycle park,
 - (iv) a zoo,
 - (v) an outdoor theatre,
 - (vi) an outdoor pool or splash pad, or
 - (vii) any other area or place that is prescribed or otherwise described in the regulations.

Owners and operators

90.29 No owner or operator of a place where the smoking or vaping of cannabis is prohibited under this Act may permit a person to smoke or vape cannabis in that place.

Traffic Safety Act, RSA 2000, c T-6

Definitions

1(1)(p)"highway" means any thoroughfare, street, road, trail, avenue, parkway, driveway, viaduct, lane, alley, square, bridge, causeway, trestleway or other place or any part of any of them, whether publicly or privately owned, that the public is ordinarily entitled or permitted to use for the passage or parking of vehicles and includes

- (i) a sidewalk, including a boulevard adjacent to the sidewalk,
- (ii) if a ditch lies adjacent to and parallel with the roadway, the ditch, and
- (iii) if a highway right of way is contained between fences or between a fence and one side of the roadway, all the land between the fences, or all the land between the fence and the edge of the roadway, as the case may be,

but does not include a place declared by regulation not to be a highway;
