3. Staff Presentation - Bylaw No. B-06/2022 - Land Use Bylaw Amendment Parking Variances (Stephen Utz, Director of CAO's Office and Willow Czaban, Senior Planner)

S. Utz, Director of CAO's Office, and W. Czaban, Senior Planner, presented Bylaw No. B-06/2022 - Land Use Bylaw Amendment Parking Variances.

It was asked whether replacing the word "may" with "shall" will substantially affect the parking requirements and what protection there will be if more parking is needed. W. Czaban advised that Planning staff aim to strike a balance between flexibility and predictability. The word "may" allows for flexibility to be able to consider things to ensure good outcomes, while "shall" gives a higher degree of predictability. As the reduction will only be for very small tenancies, a net change of 1-2 stalls will not create a significant shift in parking. S. Utz advised that the recourse would be to amend the bylaw again to increase the ratio if needed.

It was asked how more walkabout or micromobility space will be enforced in parts of the downtown. S. Utz advised that residents want to see a more complete Main Street, so the goal is to leverage the maximum value of the right-of-way.

If not enough parking is provided with the development, what will stop the general public from parking in front of their homes? What privacy measures will be put in place when the use changes from a fire hall to a public building? Mayor Brown confirmed that Council will be discussing both of those matters in great detail going forward. J. Iverson, Team Leader of Corporate Communications, advised that letters were sent to residents of Ridgegate who back onto the site. Administration will follow-up with more details as they become available. A website about the project will be available as well.

16. PUBLIC QUESTION PERIOD

Cindi, a resident of Ridgegate Way, advised that her rearyard backs on to the current fire station site. Will the current parcel that is designated M3 be turned into a parking area?

M. Lock, Director of Community Services, advised that the concept plan for the site has underground parking and surface parking on the north side of the facility, and no parking between the facility and the fence beside the Ridgegate houses. That parcel will remain a green space and sight lines have been considered to provide a good privacy buffer between the facility and residents. Correspondence has been sent to all impacted residents. M. Lock advised Cindy that if she provides Administration with her contact info, Administration will send a schematic design for the site. Y. Peng Qin confirmed that the M3 site is in the flood zone for Nose Creek, so will remain an undisturbed landscaped area.

Concern was raised that decisions could be based on a staff member's feelings rather than planning rationale. J. Ramjohn confirmed that if staff are injecting opinion, Administration will deal with that from a consistency perspective. S. Utz-noted that a land use bylaw is a regulatory application of a philosophical approach. The City is trying to break down barriers for business and a strict application of the bylaw can cause problems with business opportunity.
