The Marigold Newsletter for July/August 2023 was distributed for information.

It was asked whether anyone has ever challenged our materials. K. Lauzon confirmed that we have received materials challenges, and outlined the process for the public to challenge our materials. Both formal and informal complaints are tracked. It was noted that the Collections Management Policy needs to be updated. It was asked whether patrons can request that the library obtain materials on a certain subject. K. Lauzon advised that there is a process for requesting materials and library staff should respond to all of those requests.

It was asked whether the library has services for those with print disabilities. K. Lauzon advised that we facilitate two different services for persons with print disabilities:

The Centre for Equitable Library Services (CELA) offers materials to those who may have difficulty reading print due to visual, physical, or learning disabilities. The National Network of Equitable Library Service (NNELS) is an online repository of accessible formats for print disabled patrons that is based on user demand.

K. Lauzon noted that Airdrie does not have many customers that make use of this service currently.

It was asked whether the library has made any use of the karaoke machine kit that can be rented from Marigold. K. Lauzon was not aware of any.

A question was asked about Press books (people publishing their own materials). K. Lauzon advised that staff have all been trained on that and do
