5. PRESENTATIONS

 Circle Connections for Reconciliation - NIPD and TRC Presentation and Request for Funding and Support (Steve Ward, Team Leader Arts, Programs and Events) C. Aragon, Manager, Recreation, Culture and Social Planning, and K. Harris, Community Developer, Culture and Heritage, introduced Mr. Adrian Pruden, Co-chair, and Ms. Sue Methuen, Director, Circle Connections for Reconciliation ("the Circle"), and provided background information.

Mr. Pruden and Ms. Methuen presented Council with an overview of the plans for National Indigenous Peoples Day on June 21 and Truth and Reconciliation Day on September 30, as well as a request for funding, City support, and Mayor and Council attendance at both ceremonies to partake in gift giving protocols, land acknowledgment and speaking at the event.

Ms. Methuen advised that the Circle is recommending that the City continue to build very important relationships directly with Elders, Knowledge Keepers and Indigenous Cultural Advisors, further education for all Council members, management and staff, and that the City work directly with Elders to create a formal Truth and Reconciliation Policy for the City.

Mr. Pruden presented the cost/budget for the National Indigenous Peoples Day event on June 21, 2024. The shortfall in the budget for 2024 is \$2,500. For future years, the budget for the two main events is expected to be \$25,000-\$30,000 and the request for the next five years is \$10,000 for each event plus up to \$10,000 for other events.

Discussions took place regarding staff time used to support these initiatives and C. Aragon will do a full cost accounting going forward.

Discussions took place that there are a lot of user groups in the City that are looking for space, fee waivers and funding, and the City needs to be fair and equitable.

A comment was made that Council may need a workshop to Investigate a policy regarding Truth and Reconciliation requests from the Circle and Elders in the future.

M. Bigney confirmed that \$15,000 has been delegated for these events. The other \$15,000 has been delegated for honorariums to Elders.
