 Public Hearing / Bylaw No. B-28/2024 - Land Use Bylaw Amendment -Vantage Rise NSP Area (Tega Odogu, Planner II)

A Public Hearing is being held on Bylaw No. B-28/2024, being a bylaw to amend Section 8.1(3) of Land Use Bylaw No. B-01/2016 by redistricting 0.42ha (1.04ac) of land legally described as NE-34-26-1-W5, from Low-Rise Multifamily Residential District (R3) to Community Commercial District (C2) to provide additional commercial lands needed for the potential development of a health care centre within the Vantage Rise neighbourhood.

Mayor Brown declared the Public Hearing for Bylaw No. B-28/2024 open at 1:05 p.m.

T. Odogu, Planner II. presented Bylaw No. B-28/2024. In response to a question, T. Odogu confirmed that while there is no definitive plan for the commercial area yet, it will be located on a major corridor which is far from the residential development.
