Subject: 2024 Fall Major Capital Projects Update

Issue:

The Community Infrastructure and Strategic Growth Committee is being provided with the 2024 Fall Major Capital Projects Update for information.

Background:

The capital projects budget is comprised of a variety of significant multi-year projects. The update below provides valuable information to the Community Infrastructure and Strategic Growth Committee. Each project has a designated Project Manager responsible for construction delivery and the capital projects update. The report is crafted to identify project issues and risks including the impacts to scope, schedule, and budget.

Capital projects listed below have been filtered into "Major Capital Projects" based on the Airdrie process framework for project delivery:

- Will the project be staged over more than one year?
- Is the project multidisciplinary (2 or more) i.e., civil, structural, mechanical, electrical, environmental?
- Will the work impact existing infrastructure that must remain operational for project duration?
- Has Council prioritized project?
- Is project cost over \$200,000?

The total for 2024 Major Capital Projects is \$190,331,022, which includes \$88,805,102 of carry forward projects from prior years. The Capital Project Office currently manages 33 of these projects worth \$107,147,256. The 6 remaining projects \$83,183,766 are with the business leads and their project managers. Specifically, Airdrie Multi-Use Facility and Library, Southwest Recreation center, Finance Enterprise Software, 2 Highland Park front

lobby, expanded community use gymnasium - Airdrie Francophone High School and Administration campus.

Major Projects with identified risks:

The below projects have identified risks, noted in triple constraint (Scope, Schedule, and Cost).

Project 000051 Parks - Chinook Winds Site Development

- Ongoing negotiations with adjacent developer on boundary conditions and access to infrastructure and facilities related to storm water pond.
- Ground conditions (geotechnical) escalated costs significantly from consultant estimate. While improvements were made to existing site, some items required deferral or cancellation. Deferred items will be considered for completion in subsequent budget years.
- Some seasonal items to be completed in spring 2025.

Project 000666 Parks Operations Building – Chinook Winds

- Ground conditions (geotechnical) escalated costs significantly from consultant estimate. While intended functionality was substantially achieved, some items required deferral or cancellation. Deferred items will be considered for completion in subsequent budget years facility is operational.
- Project is in warranty.

Project 000987 Nose Creek Bridge – 8th Street North of Veterans Boulevard

- Bridge requires significant repairs; however, any improvements would trigger a full regulatory review to current standards and considerable increase in expense. Staff and consultants are reviewing what is possible to optimize these constraints.
