Minimal guidance from the province

- There are no standardized requirements / definition of criminal record check in the *Local Authority Elections Act.*

Considerations – Barriers for potential candidates

- Loss of personal privacy criminal record checks are publicly available
- Additional Cost for Candidates (around \$100)
 - Additional administrative burden on candidate on nominations process
 - CRC may take longer to process than expected
 - Ability to submit a complete nominations on-time
 - There is no legislative discretion provided to accept late and/or incomplete nominations

Vulnerable Sector Checks are not available for elected officials¹

- A candidate for nomination or an elected official does not meet the legal requirements for a vulnerable sector check. The nature of the position - not the person - must cause the person to have authority over, or trust of, children or vulnerable persons. Being in a position of trust or authority is more than just having contact with children or vulnerable persons.
