1. CALL TO ORDER

Councillor Jones called the meeting to order at 1:00 p.m. and confirmed that quorum has been met for this meeting.

2. DIRECTOR'S BRIEF (verbal only)

L. Stevens, Director Community Infrastructure, noted that Airdrie receives our treated water from Calgary. The City of Calgary recently provided a short communication that they are working on re-introducing fluoride into their water. It is expected that fluoridation will be in place by March 2025. Additional information will be provided later in February.

A question was asked whether the City of Airdrie will provide residents with options to remove fluoride in their home. L. Stevens advised that water quality treatment guidelines, both through Airdrie Health and nationally, encourage the use of fluoride in the water. We need to be mindful that providing conflicting information may not be in Airdrie's best interest.

It was asked whether there has been a significant increase in our cost to Calgary for water. L. Stevens advised that there have been no significant increases on a per cubic metre basis from the City of Calgary. Airdrie's water and sewer rates have remained relatively stable and may even have reduced slightly in the last budget cycle.

- L. Stevens confirmed that for residential units, the fixed rate per day has actually dropped from 81 cents in 2024 to 80 cents in 2025 and the consumption rate has dropped from roughly \$1.59 per cubic metre in 2024 to \$1.53 per cubic metre in 2025, being approximately a 3.8% reduction year over year in our residential water rates.
- S. Utz, Director Strategic Growth and Investment, advised that on the strategic growth services side, the Bylaw which the Committee saw in December regarding supportive housing amendments for the Land Use Bylaw was passed by Council. On the advocacy and investment side, we will be having some follow-up meetings in Edmonton this week on the Airdrie Day at the Legislature.
