PRESENTATIONS/APPOINTMENTS

C. Aragon introduced Cassandra Clem, Director of Programs and Services, Boys and Girls Club Airdrie, and Laurie Jacob Towes, Manager of Community Development, North Rocky View Community Links, who gave a presentation of the Airdrie Bullying Prevention Initiative.

Alderman Belyk commended the Boys and Girls Club and Community Links for all of the work put into this initiative and asked staff to provide him with a copy of the presentation. L. Jacob Towes advised that the schools are connected with the initiative independently, but the School Boards could be approached as well. It was suggested that the anti-bullying tip sheet be disseminated through the School Boards.

A question was raised whether this is an enhancement of existing programs.

2016 Community Investment Funds Allocation

2016 FCSS Allocation

C. O'Donoghue and C. Aragon provided information to review the 2016 Family and Community Support Services (FCSS) funding applications and to make a FCSS funding allocation recommendation to Council.

A question arose with respect to funding for 2017 and beyond. C. Aragon advised that funding this year was on an interim budget from the Province. Exact funding numbers for 2017-18 won't be available until after the budget is delivered. The recommendation will come before Council at the second meeting in October. C. Aragon confirmed that because the funds were given in the middle of the year, the City does not have to match the adjustment funds for 2015, but will have to match 2016 funding. Three-quarters of the adjustments funds will be received in October and the balance in January. Administration is recommending to hold the adjustment funds for now and decide in 2016 how best to spend the dollars to ensure that the additional projects will be preventative programs.

A question arose with respect to the process to be used to decide on allocation for the additional funding. C. Aragon advised that news of the additional funding was only received from the Province last week and staff need time to figure out the most efficient way to allocate funding.

Cultivating our Creative Community Summary Findings

Great Places Plan Update and Public Engagement Plan

K. Brinson, Parks Department Team Leader, introduced Jessica Mills, Parks Development Coordinator, who provided the Board with information on the proposed update of the Great Places Plan, including details around the public engagement process.

It was asked whether the world café will be limited to 20 people. J. Mills advised that invitations will be sent to a number of different groups, but the feeling is that it would be a more solid world café with a maximum of 20 people. It was asked how pathway users will know about the world café. J. Mills confirmed that it will be advertised through newspapers and other media avenues.

Nose Creek Park Renovation Process

- K. Brinson introduced Scott Fediow, Parks Development Technician, who provided the Board with an update on the public feedback from Phase I of the public consultation process as well as an outline of Phase II and finalization of the Enhancement Plan.
- S. Fediow confirmed that a secondary open house will be held to create two designs for the amphitheater. In response to a question, S. Fediow advised that the open concept allows more flexibility, but there will not be substantial capacity difference between the two concepts.

A question was asked that if Council does endorse the Cultural Policy, whether some of the Culture, Art and Heritage will be incorporated into this project. S. Fediow advised that the consultant has talked to members of SLAM and will be talking to the manager of Bert Church LIVE Theatre. D. Fortier noted that there will be a meeting this week on cultural mapping. Major groups that regularly use Nose Creek Park have also been involved. The Great Places Plan will be mutually beneficial for both processes.

A question arose with respect to washroom expansion. S. Fediow advised that the concession stand will be removed to expand and upgrade the washroom facilities and a new external concession stand will be built. The concept also includes solid permanent picnic tables under the overhang.

Alderman Belyk moved "that the Community Services Advisory Board accepts the report entitled 'Nose Creek Park Renovation Process' for information."
